MobilPay card payment procedure:

Step1: The client is redirected from the our website's booking page towards Netopia mobilPay payment security page. Here the client places his own card information; those information are not kept on mobilPay servers but are directly sent to the processing bank.

Step2: The processing bank transmits your client data to the issuing bank in order to receive trading acceptance.

Step3: The issuing bank response is sent to Netopia mobilPay

Step4: mobilPay sends the response back to the client, and he gets redirected to sellers website.
